Pursuant to Section 102 of the Act, the Notice along with Annual Reports were sent to the Shareholders throughemail /by courier to the shareholders, who have not registered their email ides with the Company, within the stipulated time before the AGM.

Pursuant to provisions of Rule 20 of the Companies (Management and Administration) Rules, 2014, the Company has published the Notice convening the AGMin thenewspapers viz. Free Press Journal and "Navshakti" on6th August, 2022. The clippings of the newspapers were submitted to BSE Ltd where the equity share of the company are listed / trading.

Theremote e-voting facility was kept open forthree(3) days i.e. from Monday, 12thSeptember 2022 @09:00 (IST) to Wednesday, 14thSeptember, 2022up to17:00 (IST). The Members cast their votes electronically on e-voting platform provided by the Link Intime India Private Limited on the designated website https://instavote.linkintime.co.in

Pursuant to the said Rules, after the closure of the remote e- voting, the shareholders, who have not voted through remote e-voting have been allowed to e-vote at the AGM throughthe facility provided by Link Intime Private limited.
